### **Terms of Use of the *B Rider App* Application**

As a user of *B Rider App* mobile device Application, you are licensed, not sold the App for use only under the terms of this license.

By using *B Rider App*, you signify you consent to:

- these Terms of Use; and
- the Boundary Rider Privacy Policy,

which form part of these Terms of Use. If you do not agree to these Terms of Use, then you are prohibited and must refrain from using *B Rider App*.

**Scope of License** – This license granted to You for the Licensed Application *B Rider App* by Vinehealth Australia’s Application technology partner, is limited to a non-transferable license to use *B Rider App* on any GPS-enabled mobile device that You own or control only. You may not distribute or make *B Rider App* available over a network where it could be used by multiple devices at the same time. You may not rent, lease, lend, sell, redistribute or sublicense *B Rider App*. You may not copy, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of *B Rider App*, any updates, or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by the licensing terms governing use of any open source components included with the *B Rider App* Application). Any attempt to do so is a violation of the rights of the Be Seen Be Safe Corporation and its licensors. If you breach this restriction, You may be subject to prosecution and damages.

**Consent to Use of Data** – You agree that Vinehealth Australia and their technology partner may collect and use technical data and related information, including but not limited to technical information about Your device, system and application software, that is gathered periodically to facilitate the provision of software updates and product support related to the *B Rider App* Application. Your information will not be used to market any additional products or services to you.

**Termination** – This license is effective until terminated by You, Vinehealth Australia or their technology partner. Your rights under this license will terminate automatically without notice from Vinehealth Australia or their technology partner if You fail to comply with any terms of this license. Upon termination of the license, You shall cease all use of the *B Rider App* Application, and destroy and delete from your mobile device all copies, full or partial, of the *B Rider App* Application.

**Website**– The vineyard owner or representative nominated to receive a property’s electronic visitor log will be provided with private login access to the website to view this log. Use of the website will require internet access. You agree to access the website at Your sole risk and that Vinehealth Australia or their technology partner shall not have any liability to You for content that may be found objectionable, or for any damage caused to the device from which you access the website.

Vinehealth Australia and their technology partner make every effort to ensure its location data is accurate. The location data provided by both parties is provided solely for the use of evaluating the geofencing application as a potential tool to mitigate spread of pest or disease.
