Empowering you with knowledge and resources

We have delivered important biosecurity information and tools to vineyard owners and industry to improve knowledge and raise awareness of the value of farm-gate hygiene and general biosecurity. These include our monthly e-newsletter, Biosecurity Alerts, Industry Notices, website, fact sheets, posters, signs and disinfestation kits.



100 Vinehealth Australia news articles published, with 75% e-newsletter average open rate (well above the industry average of 38%).



10 Biosecurity Alerts and Industry Notices distributed, covering key topics such as new Victorian phylloxera detections, fruit fly, Mornington Peninsula rezoning, SA's Biosecurity Bill, Board positions, Abandoned/Neglected vineyards.





50 Biosecurity Tips shared weekly with regional associations and to industry via Daily Wine News, covering Vintage Tips, Phylloxera Facts and Wine Tourism Tips.

173 Biosecurity Signs sold, with 103 being installed in SA, 57 in Victoria, 9 in NSW and 4 in Tasmania.

Extending the value of our most valuable asset, our Register

We have used our curated planting data on our Register to provide industry and government with aggregated and deidentified vineyard planting, sales and grower exit data, contributing valuable insights into grape and wine supply/demand planning.

We progressed plans for upgrading our Register to streamline our internal processes, and provide vineyard owners the ability to permission out their data held on the Register for other purposes.

Timely incident response to facilitate business continuity

Ensuring strong biosecurity for SA

Contributed detailed feedback to the state government on the draft SA Biosecurity Bill to ensure protection for the state's vineyard assets and to ensure no dilution of powers and functions under the *Phylloxera and Grape Industry Act 1995*.
